#### Call to Order

Vice-Chair Green called the meeting to order at 5:05 p.m. and noted a quorum was present.

#### Public Comment

There was no public comment.

#### Amendments to the Agenda and Approval of it

Committee approved the agenda unanimously.

#### Minutes

Minutes from the Committee's June 8<sup>th</sup>, 2015 and August 10<sup>th</sup>, 2015 meetings were approved unanimously.

#### SSPRD Updates

Melissa presented the two concept plans for the Entertainment District Park. Committee discussed the plans, the possibilities of upgrading playground equipment, and how these improvements could be phased.

Melissa updated the Committee on the budget for the project. SSPRD put aside \$500k for next year but may have spent some of that already on pre-engineering. She said a first phase might be improvements up at the northern corner of the site.

Melissa said she'd like to take Master Plan to their Board on November 11<sup>th</sup>, and that there could be more public input after that. She said the plan would include phasing to show it wouldn't all be there on Day 1. She said SSPRD plans to build at least part of it in 2016. Torie confirmed Council had given approval at their last meeting to the

contract for the Kimmer intersection, but the City had to secure approvals from business owners before proceeding.

#### Committee Updates/Committee Member Dialogue

Torie gave updates on the Lone Tree Arts Guild holiday event, the City's CBC Appreciation event on October 15, the Schweiger Ranch fall festival the previous weekend, and the arrival of Lesley's replacement Allissa Daily.

Committee Member Hardin reported that she went down to Castle Rock to see their stair incline. She said it was a very nice amenity and has a great view. Torie updated them on Council's discussion with Randy Burkhardt about that project at the September 20, 2015 Council study session.

Committee Member Beeler said she heard there was a cougar sighting near the Bluffs at Lincoln and Lone Tree Parkway. Committee Member Horbeck said there were many rattlesnakes out this year.

Vice-Chair adjourned the meeting at 5:46 pm.
