DESCRIPTION: Tavern Liquor License for United Artists Theatre Circuit, Inc. d/b/a Meadows Stadium 12, 9355 Park Meadows Drive, Lone Tree, Colorado.

SUMMARY: The application for a new Tavern Liquor License at the above location was submitted and completed in all material respects. The necessary fees accompanied the application.

This establishment is located at 9355 Park Meadows Drive. A lease agreement, Amendment to Lease Agreement and Memorandum of Lease and Second Amendment to Lease were entered into between Park Meadows Trust and United Artists Theatre Circuit, Inc. The lease expiration date is 12-31-2019.

The License Application, Red-lined Drawings of the Premises, and Summary of Petitioning are attached. Staff reviewed the following documents: The Articles of Amendment and Restatement of United Artists Theater Circuit, Inc., Unanimous Omnibus Written Consent of the Boards of Directors, Boards Managers, Managing Members or Certain Subsidiaries of Regal Entertainment Group, Certificate of Good Standing, Third Amended and Restated Certificate of Incorporation of United Artists Theatre Company, Certificate of Good Standing issued by the Colorado Secretary of State, Lone Tree Business License Application, Affidavit of Posting, Affidavit of Publication and Petitions.

Fingerprinting and background checks were submitted through CBI; no adverse comments or events being reported. All posting and publication requirements have been met and the petition results have been reviewed.

Tavern licensees shall have sandwiches and light snacks available for consumption on the premises during business hours, but need not have meals available for consumption.

**RECOMMENDED
COUNCIL ACTION:**

Convene as the Local Liquor Licensing Authority, New License Division and open the Public Hearing to consider a new Tavern Liquor License. Staff recommends approval of this application. Suggested motion: that the Local Liquor Licensing Authority, New License Division, having considered the evidence presented, 1) adopt the preliminary findings presented at this hearing; 2) find that all the criteria for issuance of the Liquor License have been met; 3) approve the application for a Tavern Liquor License conditional upon the applicant obtaining all necessary building permits and approvals; and 4) direct the Liquor License Administrator to prepare the required written documentation and submit the approved application to the State Licensing Authority in accordance with the law.

1. The petition circulation was conducted under the control of Esquire Petitioning Services, L.L.C. ("Esquire").
2. Circulators were driven to the proposed site and became familiar with the Applicant's proposed location.
3. Petitions were pre-filed according to the Licensing Authority's local rules.
4. Esquire prepared all of the petition circulation materials. Each circulator carried a clipboard and petition packet consisting of the following: a. a map of the designated neighborhood with neighborhood boundaries outlined and the proposed location of the outlet denoted by an "X"; b. a petition cover sheet stating: the Applicant's name, the trade name, the proposed location, the type of license application, the qualifications for signing the petition and the information concerning the public hearing; c. signature sheets that provided eligible persons the opportunity to sign the petition in support of, or in opposition to, the application; and d. data sheets on which to record all responses by address.

5. The circulators were instructed as follows:
 - a. to state the petition being circulated concerned an application for a New Tavern Liquor License for United Artists Theatre Circuit, Inc., dba Meadows Stadium 12;
 - b. to present the map of the designated neighborhood, state the Applicant's name, trade name and to describe the Applicant's location;
 - c. to review the qualifications for signing the petition and the petition issue;
 - d. to provide eligible persons the opportunity to sign the petition in support of, or in opposition of the application;
 - e. to witness all signatures; and
 - f. to record, by address, all responses on the data sheet.


