

Checklist for Tobacco Retailers

Use the following checklist to learn what inspectors look for and help avoid violations. See the links to local, state and federal laws related to tobacco sales on page 2.

 Definition of Tobacco Product: Any product which contains, is made or derived from tobacco or synthetic tobacco or used to d nicotine or synthetic nicotine, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed or ingested by any other means, including but not limited to cigarettes, cigars, cigars, chewing tobacco, pipe tobacco, snuff, bidis, snus, nicotine product, mints, hand gels; and b. An Electronic Smoking Device, tobacco paraphernalia, and any component, part, accessory assowith the consumption of a tobacco product(s) such as filters, rolling papers, pipes and liquids us electronic smoking devices whether or not said product contains nicotine. Clerks must ask to see ID for any tobacco product purchase to confirm that the recipient is at leas twenty-one (21) years old (regardless of the appearance/age of the customer).	t

7. Except at a location where persons under 21 are prohibited from entry, it is unlawful to sell Tobac Products by means of a self-service display, such as a vending machine.	со
Additional Colorado laws related to tobacco retail sales:	
8. It is illegal to sell individual cigarettes or any pack or container of cigarettes containing fewer than cigarettes, or roll-your own tobacco in any package containing less than .60 ounces of tobacco.	twenty
9. Every store that sells tobacco is ALSO required by State law to have "Warning" sign posted in a proplement of three inches and a width of six inches. C.R.S. § 44-7-103. The sign read as follows:	
WARNING	
IT IS ILLEGAL FOR ANY PERSON UNDER TWENTY-ONE YEARS OF AGE TO	
PURCHASE CIGARETTES, TOBACCO PRODUCTS, OR NICOTINE PRODUCTS,	
AND, UPON CONVICTION, A \$100.00 FINE MAY BE IMPOSED.	
Additional Federal laws related to tobacco retail sales:	
10. Cigarette vending machines are prohibited in any business that allows entry to those under 21.	
11. It is illegal to give away free samples of cigarettes or smokeless tobacco.	
12. It is illegal to sell or give away items such as hats, t-shirts, or lighters with tobacco brands or logos	·-
13. It is illegal to sell flavored cigarettes (except menthol and tobacco flavors)
