Instructions for Filing a Sales Tax Return for the Purchase of a Business

- 1. Complete the "Sales Tax Return for the Purchase of a Business" form. Do not leave any items blank unless you do not have the information that has been requested. If you need additional space for completing the form, please attach an additional sheet of paper.
- 2. Under the "Purchase and Sales Tax Information" section, the "Purchase Price of Business" is the full amount paid for the business. The "Price of Property" is the total amount that was paid for the tangible personal property only (such as furniture, fixtures, appliances, equipment, other applicable fixed assets, and inventory that is not for resale.)
 - NOTE: If the items purchased are being placed on a depreciation schedule for Federal and State income tax purposes, then the "Price of Property" amount reported to the City should be the greater of the property price included in the purchase agreement OR the original cost amount placed on the depreciation schedule.
- 3. Please provide a complete description of the property items included on this return. If necessary, a separate listing of property purchased can be attached to this form.
- 4. The City requires that a full copy of the Purchase Agreement be provided in addition to the completion and filing of this form.
- 5. After calculating the full amount of tax due, including penalty and interest if applicable, please make payment to:
