Submittal Requirements

- 1. A minimum of 48 hours is required for permit review.
- 2. The applicant shall provide one (1) copy each of the following documents. Electronic files are strongly encouraged.
 - a. Complete permit application
 - b. Plans of proposed work
 - c. Site map
 - d. Traffic control plan
 - e. Sediment and erosion control plan
 - f. Construction materials submittals as determined by the City
 - g. Testing reports for compaction, concrete and asphalt
 - h. Pre disturbance pictures
- 3. Permit requirements, fees and policies can be found on-line at:
 - a. http://cityoflonetree.com/government/departments and divisions/public works/permits and inspections/
- 4. Plans shall be legible and presented as Letter Size (8.5" x 11") or Ledger Size (11" x 17"). Plans shall indicate North with an arrow, limits of work (with dimensions), proximity to roads and traffic, buildings or other structures. Existing or proposed easements, public right of way and private properties shall be indicated. Plans shall also include areas of restoration to the affected roadway section.
- 5. A Site Map shall indicate location of work and identify the nearest cross streets and/or intersection.
- 6. A Traffic Control Plan shall accompany each permit application. It shall be prepared and signed by a certified Traffic Control Supervisor, and conform to current Manual of Uniform Traffic Control Devices criteria.
- 7. Methods of reducing sediment transport and erosion controls shall be shown on the plans and implemented in the field. This shall include materials handling, stockpiles, spill containment and final restoration.
- 8. Itemized quantities shall be shown on the permit with calculated fees. These quantities for both new items and associated repair items will be assessed by the City to determine the actual permit fee. All fees shall be paid in advance of the permit issuance by cash, check or credit card.
- 9. For any work in the public right-of-way which includes excavation, the applicant shall provide an itemized cost estimate of total construction costs prepared by an engineer. This amount will be used for the required surety or \$5,000, whichever is greater. The surety, if required, shall be cash, cashier's check, corporate check or irrevocable letter of credit. The LOC shall include name and address of applicant, address of permitted work, cost of work, and list the City of Lone Tree as the sole obligee.
- 10. City may accept a blanket surety for multiple projects within a determined time period in the form of cash or check only, and subject to the following requirements: applicant and contractor must be current in all payment obligations to the City, must be and remain in compliance with all applicable City requirements, amount of surety must be based on estimate of 100% of total cost of work for all projects covered by blanket surety, and City otherwise determines blanket surety is in the public interest. City reserves right to request additional surety if it determines that scope or cost of work will exceed posted surety amount.
- 11. Contractor shall provide the City a Certificate of Liability Insurance listing the City of Lone Tree as Additional Insured and carry limits as listed in our Municipal Code Sec. 11-7-90.
- 12. The permit fee shall be considered a deposit for reviews and inspections of the approved work. Any additional fees or inspections accumulated over this amount will be assessed on a per hour basis plus 15% for administrative costs. If such additional amounts are not paid when required by the City, the City may suspend or terminate the work described on Page 1 of this permit application.\
- 13. See City of Lone Tree Pavement Cut and Specifications for all street cuts. https://cityoflonetree.com/departments/public-works/engineering/
- 14. Restoration activities including permanent street cut patches shall be completed within five (5) calendar days of underground work being completed.
- 15. Reinstatement Fee after a "Stop Work Order" shall be \$600.00.
- 16. Working without City issued permit will result in an assessment of two (2) times the Permit Fees.
- 17. Each approved project construction plan set requires a separate permit.
- 18. All utility markings shall be fully and completely removed from public rights-of-way no later than forty-five (45) days after completion of the work.
- 19. Applicant shall coordinate work and restoration with affected property owner or district responsible for maintenance. When project is complete, applicant shall provide a letter or an existing agreement from each owner adjacent to the work stating that all landscaping has been restored.
